

Announcement of an audition for the artistic jury to meet the conditions for obtaining a license as a “street artist” on the territory of the City of Brussels

Audition

On 08/11/2021, the Culture Service of the City of Brussels will organize an audition for street artists in the context of the Decision of the City Council of 16/06/2014: Regulations for street artists, #amendment

The audition will take place at the Culture Service, Sint-Katelijnestraat 11 – 1000 Brussels. This audition is for street artists who have not previously received a permit from the City of Brussels and who do not have a diploma from the artistic sector.

Important comments:

Only non-enhanced performers will be able to obtain a license on the territory of the City of Brussels.

The permit will be valid for one month and an application for renewal must be submitted before the end of the month in accordance with the procedure described below.

Street artists are reminded to respect the regulations and to adhere to the specified places and times.

Violations of the regulations will be punished with administrative sanctions and lead to a ban on playing for up to one year on the territory of the city of Brussels.

Below is the procedure to follow to obtain a permit

If you have already received a permit in the past:

Then put the following documents in an envelope marked 'street artists':

- 'Application form for the renewal of a permit for the occupation of public space for an artistic activity' (downloadable from the website www.brussels.be)
- A passport photo
- For Belgians and EU citizens: copy of your identity card
- For non-EU citizens and citizens from non-Schengen countries: copy of your valid passport, or annex 3 TER, or a valid residence permit.

You hand over the envelope to a representative of the artistic jury between 14:00 and 15:30 or put it in the green mailbox before 08/11/2021 09:00 am in the 'Street Artists' mailbox.

If you have never received a permit:

If you are in possession of a diploma from the artistic sector:

Then put the following documents in an envelope marked 'street artists':

- A copy of your artistic diploma
- Completed the 'Application form for the occupation of public space for an artistic activity' (downloadable from the website www.brussels.be).
- 1 passport photo

- For Belgians and EU citizens: copy of your identity card
- For non-EU citizens and citizens from non-Schengen countries: copy of your valid passport, or annex 3 TER, or a valid residence permit.

You hand over the envelope to a representative of the artistic jury between 14:00 and 15:30 or put it in the green mailbox before 08/11/2021 09:00 am in the 'Street Artists' mailbox.

If you do not have a diploma from the artistic sector:

- Then you must audition (on 08/11/2021 between 14:00 and 15:30); later dates and times will be communicated in advance on the website www.brussels.be/audition-straatartiesten.
- Fill in the 'Application form for the occupation of public space for an artistic activity' (downloadable from the website www.brussels.be).
- 1 passport photo.
- For Belgians and EU citizens: copy of your identity card.
- For non-EU citizens and citizens from non-Schengen countries: copy of your valid passport, or annex 3 TER, or a valid residence permit.

Issuance of the permit

The permits will be delivered on Tuesday afternoon 16/11/2021 between 2 pm and 4 pm.

You must be able to provide us with all original documents of which you had to provide us with a copy.

Only fully and correctly completed application forms, with all required documents attached, will be considered.
